

## OPTION 1 FULL DAYCARE NON-FUNDED

Our Full Daycare fees are fully inclusive. They include all meals ( breakfast and hot lunch (morning session), high tea (afternoon session), fruit and snacks, while babies receive organic purees and formula milk. Nappies, wipes and sun cream are also provided by us with us no extra charge.

Additionally, as a parent you will be able to:

- Choose start and finish date at nursery (on usual notice)
- Receive full daycare (part time or full time) throughout the year
- Secure for the future your child's place in nursery, right up to departure for school
- Book extra sessions where available
- Have the opportunity to sell sessions when on holiday
- Change days of attendance, where available and on usual notice
- Book early drop-off and late pick up.
- Receive a sibling discount

Finally, you will receive a free Bluebell tee-shirt for your child upon registration and, on leaving, a free CD-ROM of your child's learning journey throughout his or her time in nursery.

### Fees for Full Daycare Non-Funded Effective 1<sup>st</sup> September 2017

Our fees for 2017/2018 will be as follows:

**1. Children aged 0 – 2 years**

Full week	£219.00 per week
Day (8am –6pm)	£49.00 per day
Session morning (8am-1pm)	£30.75 per session
Session afternoon (1pm-6pm)	£30.75 per session

**2. Children aged 2 - 3 years**

*Applies from the start of the month following the child's 2<sup>nd</sup> birthday*

Full week	£205.00 per week
Day (8am –6pm)	£45.25 per day
School day (8.15 – 3.45)	£38.00 per day <b>(Bluebell Hill only)</b>
Session morning (8am-1pm)	£28.75 per session
Session afternoon (1pm-6pm)	£24.50 per session

**3. Children aged 3-5 years**

*Applies from the start of the month following the child's 3<sup>rd</sup> birthday*

Full week	£203.00 per week
Day (8am-6pm)	£45.00 per day
School day (8.15 – 3.45)	£37.75 per day <b>(Bluebell Hill only)</b>
Session morning (8am-1pm)	£28.50 per session
Session afternoon (1pm-6pm)	£24.25 per session

**4. Early opening, late closing (both age groups) and additional single part/full hours outside of funded sessions**

For parents who require this, we can offer early starts or late finishes and additional part/full hours. The price is £5.00 per half hour or part half hour outside of our normal session times.

For terms of payment, please see our Terms and Conditions.

A non-refundable fee of £25 is payable on registration, along with an £80 refundable deposit for securing a place.

Fees are charged on a monthly basis.

Fees are payable monthly in advance, by standing order or BACS by the last day of the preceding month or by cheque by the 24th of the preceding month.

The nursery closes at 1pm Christmas Eve, for the period in between Christmas and New Year and on bank holidays. No charge is made during scheduled nursery closures.



## **OPTION 2**

### **FULL DAYCARE FUNDED 3-5 YEAR OLDS**

#### **PART-TIME or FULL-TIME**

Parents of children who attend nursery all year round (either part-time or full-time) and who are eligible for EYEE funding can claim their funding during the term time part of the year.

If you who wish to receive the benefits of full daycare (either part-time or full time) at the same time as receiving EYEE funding you will be offered our Full Daycare Funded option. In return for a Service Fee charged during term time, you will be able to:

- Choose start and finish date at nursery (on usual notice)
- Receive full daycare (part time or full time) throughout the year
- Secure for the future your child's place in nursery, right up to departure for school
- Book extra sessions where available
- Have the opportunity to sell sessions when on holiday
- Change days of attendance, where available and on usual notice
- Book early drop-off and late pick up.
- Receive a sibling discount

All meals (breakfast, lunch and tea) while your child is at the nursery are included within the FULL DAYCARE FUNDED option. Also, you will receive a free Bluebell tee-shirt for your child upon registration and, on leaving, a free CD-ROM of your child's learning journey throughout his or her time at nursery.

The Service Fee will be charged during the 38 weeks per year of EYEE funding. The remaining weeks of the year when the nursery is open will be charged at our usual Daycare Non-Funded rate.

Under the FULL DAYCARE FUNDED option, funded care will be provided in blocks of five hours ( ie. a complete session), with a maximum of two sessions (10 hours) per day.

#### **BACKGROUND**

##### **EYEE funding – 3 & 4 year olds (38 weeks per year – TERM TIME ONLY)**

###### **15 hours**

All 3 & 4 year old children can claim up to 15 hours of free childcare per week for up to 38 weeks per year, term time only. It starts at the beginning of term following their 3<sup>rd</sup> birthday and finishes when they leave for school.

###### **30 hours**

3 & 4 year old children of eligible working parents can, in addition to the 15 hours above, also claim up to a further 15 hours of free childcare per week for up to 38 weeks, term time only. The maximum claim is therefore 30 hours per week. It starts at the beginning of term following their 3<sup>rd</sup> birthday and finishes when they leave for school.

## OPTION 3A & 3B

### EYEE FUNDING – FREE ENTITLEMENT 2 YEAR OLD CHILDREN-

Central government and local authorities provide funding (EYEE funding) to assist with nursery places for children who meet their eligibility criteria. To find out whether or not you are eligible to receive funding, please visit [www.childcarechoices.gov.uk](http://www.childcarechoices.gov.uk)

EYEE funding is available as follows:

#### **3A) FREE CHILDCARE HOURS FOR ELIGIBLE TWO YEAR OLDS**

##### **ELIGIBLE TWO YEAR OLDS ONLY**

##### **UP TO 15 HOURS PER WEEK, TERM TIME ONLY (ie. 38 weeks per year in total)**

Eligible 2 year old children can claim up to 15 hours of free childcare per week for up to 38 weeks a year, term-time only. It starts at the beginning of the term after their 2<sup>nd</sup> birthday and finishes at the end of the term in which they reach 3 years of age. Once 2 year old funding finishes, parents must make a new application for any 3 year old funding which they believe might be applicable.

Funded hours for 2 year olds at Bluebell Nurseries are 8.30 – 11.30am and 1.00pm- 4.00pm from Monday to Friday. Places offered are limited and allocated termly on a first come first served basis. These hours are during term time only.

The maximum entitlement is 5 sessions of 3 hours each week, totaling 15 hours per week for a maximum of 38 weeks per year, subject to availability.

**3B)** However, funded children can also extend any session to 5 hours, of which 3 hours will be funded with the parent paying for the additional two hours. The rate payable for these additional hours is as follows:

<b>School Day (claiming 3 hours)</b>	<b>£4.84 per hour*- <i>Bluebell Hill Only</i></b>
<b>School Day (claiming 6 hours)</b>	<b>£4.50 per hour*- <i>Bluebell Hill Only</i></b>

#### **FREE CHILDCARE HOURS FOR ALL THREE & FOUR YEAR OLDS (15 HOURS)**

**ALL 3 & 4 YEAR OLDS.**

**UP TO 15 HOURS PER WEEK, TERM TIME ONLY (ie. 38 weeks per year in total)**

All 3 & 4 year old children can claim up to 15 hours of free childcare per week for up to 38 weeks, term time only. It starts at the beginning of term following their 3<sup>rd</sup> birthday and finishes when they leave for school.

Funded hours for 3-4 year olds at Bluebell Nurseries are 8.30 – 11.30am and 1.00pm- 4.00pm from Monday to Friday. Places offered are limited and allocated termly on a first come first served basis. These hours are during term time only.

If a parent wishes to access full day care (either sessional or full time) all year round, while claiming their EYEE funding entitlement, then we offer an alternative Full Daycare Option. Please see the separate Full Daycare Funded information sheet.

#### **FREE CHILDCARE HOURS FOR ELIGIBLE THREE YEAR OLDS (30 HOURS)**

**3 & 4 YEAR OLD CHILDREN OF ELIGIBLE WORKING PARENTS**

**UP TO 30 HOURS PER WEEK, TERM TIME ONLY (ie. 38 weeks per year in total)**

3 & 4 year old children of eligible working parents can claim up to an additional 15 hours of free childcare per week for up to 38 weeks, term time only. It starts at the beginning of term following their 3<sup>rd</sup> birthday and finishes when they leave for school.

Funded hours for eligible 3-4 year olds at Bluebell Nurseries are 8.30 – 11.30am and 1.00pm- 4.00pm from Monday to Friday. Places offered are limited and allocated termly on a first come first served basis. These hours are during term time only.

If a parent wishes to access full day care (either sessional or full time) all year round, while claiming their EYEE funding entitlement, then we offer an alternative Full Daycare Funded Option. Please see the separate Full Daycare Funded information sheet.
